## REACH and RoHS Declaration

### REACH Regulation (Directive 2006/1907/EC dated 18/12/2006)

In accordance with CE Nr. 1907/2006 regulation of the European Parliament relative to the registration, evaluation, authorization and restriction of the Chemical substances (REACH) and with reference to the "Candidate List" of the highly dangerous substances (SVCH) published by ECHA (European Chemical Agency),

the undersigned declares that our products do not contain any of the substances listed in the attachment XIV in concentration exceeding 0,1% in weight.

We also guarantee that our products are exempt from the substances listed in Annex XVII of Reach regulation.

KASK SpA, in order to fulfil the REACH Regulation requests, has:

- verified with its supply chain whether the articles supplied contain SVHC substances of the "candidate list" above the legal threshold (0.1% w/w).
- verified from its suppliers that all substances as they are or in mixtures subject to REACH have been registered or pre-registered by them (or upstream entities) according to REACH.
- verified that the substances used in the manufacture of its products are used under the intended conditions of use.
- in case a supplier fails to comply with one of the above points, decided to find valid REACH-compliant alternatives so as to ensure continuity of supply.
- on the basis of the information received, verified the possible presence of SVHC substances in the products supplied to the customer.

### RoHS (Directive 2011/65/EU and Directive 2015/863/EU)

With reference to Directive 2011/65/EU (RoHS2) and its updated Delegate Directive 2015/863/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment (RoHS), KASK SpA declares that its products comply with the limits set out in Annexes II.

RoHS compliant means that where the product falls under the scope of the EU RoHS Directive, this product does not contain the following substances:

- Mercury (Hg ) 0.1% - Lead ( Pb ) 0.1% - Cadmium ( Cd ) 0.01% - Hexavalent Chromium ( Cr6+ ) 0.1% - Polybrominated Biphenyls ( PBB ) 0.1% - Polybrominated Diphenyl Ethers ( PBDE ) 0.1% - Bis(2-ethylhexyl) phthalate (DEHP) 0.1 % - Butyl benzyl phthalate (BBP) 0.1 % - Dibutyl phthalate (DBP) 0.1 % - Diisobutyl phthalate (DIBP) 0.1 %

in excess of the indicated maximum concentration values by weight in homogenous materials, unless the substance is subject to an exemption specified in the Directive.

This declaration represents the Company's knowledge and belief which is partially based on information provided by third party suppliers.

This guarantee is valid for all the products and with no time limit unless we advise otherwise in writing.
